**DISCLOSURE PURSUANT TO RULE 13.18
OF THE LISTING RULES**

This announcement is made pursuant to Rule 13.18 of the Listing Rules in respect of the general banking facility in an aggregate amount of HK\$100,000,000 offered by the Bank and accepted by Condo HK, a wholly-owned subsidiary of the Company, and the Company on 9 April 2015.

The Bank requires, among other things, a minimum shareholding maintained by the controlling shareholder of the Company for the aforesaid facility.

This announcement is made by Minmetals Land Limited (the “Company”) pursuant to Rule 13.18 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”).

On 9 April 2015, Minmetals Condo (Hong Kong) Engineering Company Limited (“Condo HK”, a wholly-owned subsidiary of the Company), as borrower and the Company, as guarantor, accepted the offer from a bank (the “Bank”) for the grant of general banking facility in an aggregate amount of HK\$100,000,000 (the “Facility”). The Facility has no fixed term and is subject to periodic review of the Bank.

As one of the conditions of the Facility, China Minmetals Corporation (“CMC”, the ultimate controlling shareholder of the Company), shall remain the single largest shareholder of the Company maintaining at least 31% of the beneficiary interest of and have management control over the Company. Upon a breach of the aforesaid condition, the Bank may suspend, withdraw or make demand for repayment of the whole or any part of the Facility offered to Condo HK.

As at the date of this announcement, CMC indirectly holds approximately 62% of the issued share capital of the Company.

The Company will make continuing disclosure pursuant to Rule 13.21 of the Listing Rules.
